BUDGET PROMISES: BEYOND PARLIAMENT

"Budget Promises: Beyond Parliament" is a pioneering online platform that tracks the government's performance in delivering on its budget promises.

The platform was launched in 2017 and seeks to answer two basic questions about the promises the government makes in its annual Budget Speech:

- Is the government doing what it is saying?
- Is the government saying what it is doing?

By giving the public access to the answers to these questions, the dashboard aims to;

- (i) Improve visibility of the government's budget promises; and
- (ii) Hold it accountable for these promises.

HOW IT WORKS

The 2023 mid-year assessment tracked 25 expenditure proposals and 7 regulatory proposals explicitly proposed in the 2023 Budget Speech. While the former had expenditure allocations and resulting quantifiable outcomes, the latter required legislative enactments or regulatory notifications (gazettes) to have effect.

The platform is updated twice a year. Proposals are assessed using two indicators: Openness and Progress. The mid-year assessment assesses the progress and openness of the proposals for the first six months of the respective year.

While the research team tracked the online proactive disclosure of relevant information, it relied primarily on Right to Information (RTI) requests filed with implementing agencies via the Right to Information Act No.12 of 2016. For the 2023 mid-year assessments, the requests were filed on the following dates: 26th of July, 10th and 15th of August 2023. The information for assessment was accepted from agencies for a period of 21 working days. Any information received beyond this period was not considered for assessment.

OPENNESS TRACKER

This indicator tracks the extent to which the government is **saying what it is doing**. It measures the government's level of disclosure of information about the implementation of each decision/proposal. In short, this indicator tracks transparency.

The mid-year assessment measures the extent to which the government has been open about disclosing information on the implementation of the first six months of progress on the proposals. The year-end assessment measures the government's openness on disclosing information on progress for expenditure and regulatory proposals for the full year.



Openness is based on the information available at the time of assessment and is categorized as follows:

	Restricted	Information insufficient to determine any progress.
	Uncooperative	Information provided upon request after much effort.
	Responsive	Information available upon request in a timely manner.

PROGRESS TRACKER

This tracks to what extent the government is **doing what it is saying**. It evaluates the level of progress of the government in implementing the promises, based on timelines and milestones established by the agency responsible.

For the mid-year assessment progress is categorised for expenditure proposals as follows:

However, a circular dated 2023.02.06 issued by the Department of Samurdhi Development that lists down the instructions on the approval of recipients and cash transfers for January 2023 was available online. This circular has been shared with the Ministry of Women, Child Affairs and Social Empowerment, National Secretariat for Elders and the National Secretariat for Persons with Disabilities. However, no further information was proactively available online. A Right to Information (RTI) request was filed on the 15th of August 2023; however, no response was received from the implementing agency despite multiple follow-ups. An RTI request was filed on the 26th of July 2023 and information was received on the 23rd of August 2023, which is outside the 14 days from the date the RTI request was filed but within 21 days. Information was provided on financial targets and performance of certain sub-projects under the proposal for the first two quarters of 2023. However, information about targets and progress of activities accounting for nearly 50% of the total allocation was not provided. Thus, the information provided was insufficient to carry out an assessment of the overall progress of the proposal.	No information was available online to assess the progress of the proposal. As per the RTI response from the implementing agency (Road Development Authority), the total allocation of Rs. 2,000 million was divided by province/division into five categories: Construction Division (Rs. 900 million), Sabaragamuwa Province (Rs. 397.17 million), Central Province (Rs. 449.99 million), Uva Province (Rs. 83.05 million) and Southern Province (Rs. 169.79 million). As per the initial RTI response from the implementing agency, it was stated that an inquiry had been submitted to the Department of Treasury Operations (DTO) on the 16th of June 2023 on the disbursement of funds to implement the proposal. However, the DTO had not responded to the implementing agency. Furthermore, it is expected to provide loans to 610 beneficiaries in 61 divisional secretariats. As per the second RTI response from the implementing agency (Ministry of Women, Child Affairs and Social Empowerment), the initial RTI had been transferred to three agencies: National Secretariat for Elders, National Secretariat for Persons with Disabilities and the Department of Samurdhi Development. In pursuit of this goal, the government has engaged with the Australian Productivity Commission. However, in a response dated 10th August 2023 (within 14 days of the date on which the RTI was filed) from the Ministry of Industries, it was stated that the budget proposal 'National Productivity Commssion' did not fall within the purview of the Ministry of Industries. The response further stated that the same had been communicated to the Presidential Secretariat in a letter dated 2023.03.28.
